RAISING A READER (RAR) IS A NATIONAL NONPROFIT FAMILY ENGAGEMENT AND LITERACY PROGRAM THAT HELPS FAMILIES DEVELOP, PRACTICE, AND MAINTAIN HOME LITERACY HABITS ESSENTIAL FOR SCHOOL SUCCESS. RAR IS OPERATED THROUGH A DIVERSE NATIONAL NETWORK OF AFFILIATES (E.G., SCHOOL SYSTEMS, LIBRARIES, OR COMMUNITY AGENCIES) AT MORE THAN 2,900 LOCATIONS NATIONALLY, SERVING FAMILIES WITH CHILDREN BETWEEN THE AGES OF 0 TO 8 YEARS OLD. CHILDREN PARTICIPATING IN OUR PROGRAMS ARE EXPOSED TO HIGH-QUALITY, DEVELOPMENTALLY APPROPRIATE CHILDREN'S BOOKS, PROVIDING THEM WITH BOTH A MIRROR REFLECTING THEIR OWN WORLD AND A WINDOW TO THE WORLD BEYOND.
